NOTICE OF RACE

The regatta activities must be carried out in accordance with the provisions on the fight and containment of diffusion of COVID 19 issued by the Italian Federation. The Organizing Committees will activate these provision and all participants must adhere under the supervision of the Organizing Committee itself.

In the case that any cases of Covid 19 will be detected during the event. These will be reported by the Organizing Committee to the competent health authorities in charge.

The notations in a rule: **[DP]** means that a penalty for breach of that rule may, at the discretion of the Jury, be less than disqualification. **[NP]** means that a boat can't protest for a breach of this rule.

1) ORGANIZING AUTHORITY

The Carnival Race is organized by the Yacht Club Sanremo, by delegation of the Italian Sailing Federation.

2) RULES

• **[DP][NP]** The special regulation "PROTOCOLLO DI REGOLAMENTAZIONE DELLE MISURE PER IL CONTRASTO ED IL CONTENIMENTO DELLA DIFFUSIONE DEL COVID-19 NELLE SOCIETÀ E ASSOCIAZIONI SPORTIVE AFFILIATE" (further referenced to as "Covid Protocol"), issued by National Authority Federazione Italiana Vela FIV (Italian Sailing Federation), , version updated October 8th, 2020 or any subsequent versions, published on <http://www.federvela.it/news/2718-aggiornato-il-protocollo-di-sicurezza-federazione-italiana-vela.html>.

• - the *Rules* as predefined in WS Racing Rules 2021-2024 (RRS), included valid Prescriptions of the Italian Sailing Federation FIV, which are available in English at https://www.sailing.org/documents/racingrules/national_prescriptions.php and which will be posted in the on line ONB.

- – For the Italians competitors the "Normativa" of the Italian Sailing Federation will apply.
- – The official language of the event is English
- – In case of conflict between NOR and SI, the SI will take precedence; this modify RRS 63.7.

3) COMMUNICATIONS

- In compliance with Covid Protocol, Official Notice Board (ONB), communication to competitors and from competitors to the OA, CR and Jury, shall be done only as an Online Official Notice Board, available at the following link <https://www.racingrulesofsailing.org/documents/3146/event> or QR code:



FOR FULL EFFICENCY OF THE DESCRIBED SYSTEM, IT IS COMPULSORY THAT ALL CREWS (HELMSMAN AND BOWMAN) WILL INFORM OA BY THE ENTRY FORM THE OWN EMAIL ADDRESS AND WHATAPP PHONE NUMBER.

Each crew is responsible to adjust yourself to such system.

4) ADVERTISING AND OTHER IDENTIFICATION

- – Boats may be required to display advertising and identification stickers chosen and supplied by the organizing authority, in accordance with Advertising Code, Regulation 20.4 WS
- -The Organizing Authority reserves the right to refuse advertising by a boat or competitor when it is in conflict with the laws of the Italian government or Italian Sailing Federation.
- – Boats of 470 Women and 420 Ladies classes shall carry the red square identification on both side of the mainsail.

5) ELIGIBILITY AND ENTRY

- WS Regulation 19 “Eligibility Code” applies
- The event is open to following classes: 420 Men/Mixed and Ladies, 470 Men/Mixed and Women.
- For the 470 class the regatta it's the 1th National Race valid for the ranking list. The Italian sailor they will have e classification extrapolated from the general classification.
- 420 Men/Mixed and 420 Women ,470 Men/Mixed and 470 Women classes will sail in the same fleet and will have different classification, unless the number of entries will be significant so they may sail in different fleets.
- Eligible boats may enter by completing the form available online at www.yachtclubsanremo.it and paying the relevant entry fee before February 7, 2022. Registrations will also be accepted after February 7 with an extra euro 50,00.

6) FEES

Required fees are as follows:

470 M/M&W, 420 M/M&L: **Euro 150.00 before February 7, 2022; Euro 200.00 after February 7, 2022.**

Payment of the registration fee is not refundable.

7) INSURANCE

- – All boats competing in this event shall have third party insurance cover not less than 1.500,000 EURO for any accident. Each competitor must produce at Registration the form attached to this NOR duly filled: entries of competitors not holding such document will be not accepted. A copy of the Insurance shall be preliminary sent during the on-line registration and then also produced at Registration office during the final Registration procedures.
- – this rule not apply to the competitors holding the card FIV PLUS.

8) QUALIFYING SERIES AND FINAL SERIES

The organizing authority reserves the right to divide the 420 Open fleet and run qualifying and final series, according to the number of entries. Details will be given on the SI, and announced within 10:30 am of Thursday 17th.

10) MEASUREMENTS

The valid measurement certificates shall be presented at registration.

11)SAILING INSTRUCTIONS

The SI will be available on the on-line ONB since Wednesday 16th, 2022.

12) THE COURSES

Details of Courses will be given in the Sailing Instructions

13) SCORING

- – One race is required to be completed to constitute a series.
- – Discards:
- When from 1 to 4 races have been completed, a boat's series score will be the total of her race scores.
- When from 5 to 11 valid races have been completed, a boats series score will be the total of her races scores excluding her worst score.

14) BOATS OF SUPPORT PERSONS

- Boats of support persons shall be marked with a flag or sticker supplied by the organization and shall register at the registration desk before 10.00 a.m. of 18 February.
- – Evidence of Third Party insurance for each support boat shall be produced during registration.

15) BERTHING

Boats shall be kept in their assigned area in the boat park.

16) PRIZES

420 class:

Will be awarded: the first five boats classified for each groups (open and women); the first crew Under 17; the first three mixed crew classified.

470 class:

Will be awarded: the first three boats classified; the first three women crew classified; the first three mixed crew classified.

17) DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 3, Decision to Race. The Organizing Authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.

Recalling the Fundamental Principle that mentions: "Participants are invited to minimize any negative environmental impact of the sport of sailing", it is recommended that the utmost attention be paid to protecting the environment in all moments that accompany the practice of the sport of sailing first, during and after the event. In particular, attention is drawn to RRS 47 - Waste Disposal - which reads: "Competitors and support persons must not deliberately throw waste into the water. This rule always applies when in the water. The sanction for an infringement of this rule may be less than disqualification".

18) RIGHTS TO USE NAME AND LIKENESS

In participating in an event, a competitor automatically grants to the Organizing Authority and the sponsors of the event, the right in perpetuity, to make, use and show, from time to time and at their discretion, any motion pictures, still pictures and live, taped or film television and other reproductions of him/her during the period of the competition for the said event in which the competitor participates and in all material related to the said event without compensation.
